## **Board Authority and Establishing Fees**

#### AGCO Board Resolution

WHEREAS on a date to be proclaimed, the Alcohol, Cannabis and Gaming Regulation and Public Protection Act, 1996 (ACGRPPA) will be repealed and the Alcohol and Gaming Commission of Ontario Act, 2019 (AGCOA) will come into force;

**AND WHEREAS** on a date to be proclaimed, the *Liquor Licence Act* and the *Liquor* Control Act will be repealed and the Liquor Licence and Control Act, 2019 will come into force:

**AND WHEREAS** section 3 of the AGCOA provides, among other things, that the Alcohol and Gaming Commission of Ontario (AGCO) shall be responsible for the administration of the alcohol, cannabis, gaming and racing statutes and regulations made under them;

**AND WHEREAS** paragraph 13(1)(a) of the AGCOA provides the Board, subject to the approval of the Minister, with the continued authority to establish fees or other charges for the purposes of the AGCOA and for the administration of any of the alcohol, cannabis, gaming and horse racing statutes (or any regulations made under them) referenced in section 3 of the AGCOA:

## THEREFORE BE IT RESOLVED THAT::

1. The Board establishes under paragraph 13(1)(a) of the AGCOA, subject to the approval of the Minister, the fees and other charges with respect to the Liquor Licence and Control Act, 2019 (LLCA) and the regulations made thereunder. Such fees and other charges with respect to the LLCA and the regulations made thereunder are set out in the attached "Schedule A".

Paragraph 1 is effective on the date that the AGCOA and LLCA come into force, subject to approval of the Minister.
