IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF Garry M. Merner

On January 21, 2023, the standardbred horse "BELECHICK" (tattoo number 1TM90) finished sixth (6th) in the eighth (8th) race at Woodbine Mohawk Park Raceway. BELECHICK is trained by GARRY MERNER". The horse was selected for pre-race testing and was identified by test tag number 532302116.

On January 24, 2023, Racing Forensics Inc. reported that the blood sample with Test Tag number 532302116, contained TC02 with a value measured at 38.7 mmol/L.

On January 23, 2023, the standardbred horse "QUAN BLUE CHIP" (tattoo number 4PM04) finished fifth (5th) in the sixth (6th) race at Woodbine Mohawk Park Raceway. QUAN BLUE CHIP is trained by MERNER. The horse was selected for pre-race testing and was identified by test tag number 532302312.

On January 26, 2023, Racing Forensics Inc. reported that the blood sample with Test Tag number 532302312, contained TC02 with a value measure at 37.6 mmol/L.

TAKE NOTICE that based on the above MERNER is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

In accordance with Rules 4.02(i), 6.04 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, MERNER is hereby fully suspended for sixty (60) days (April 7, 2023, to June 5, 2023, inclusive) and issued a monetary penalty of three thousand (\$3,000) dollars.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, BELECHICK and QUAN BLUE CHIP are hereby declared unplaced for all purposes, with the exception of Pari-Mutuel Wagering.
